#### Nova Southeastern University (NSU)/Larkin PM&R Residency Update

Dear Acting Administrator Slavitt,

The undersigned organizations write you today to express our interest in ensuring optimal and high quality electrodiagnostic (EDX) medical care is delivered to all patients. We are concerned that deep cuts in the reimbursement rates to needle electromyography (EMG) and nerve conduction studies (NCS) did little to reduce the fraud and abuse driving increased utilization and may further harm patient access by straining qualified healthcare providers operating in this important space. We encourage the Centers for Medicare and Medicaid Services (CMS) to protect patient health by working with the stakeholder community in a meaningful way to collaboratively pursue efforts which ultimately ensure that patients receive EMG and NCS testing only from healthcare providers that can meet objective quality standards. In this regard, we offer ourselves as a resource and hope to establish a working relationship with CMS.

For serious and progressive conditions such as ALS, muscular dystrophies, and various neuropathies, an early and accurate diagnosis through EDX testing is essential to ensure timely patient access to life-sustaining or life-improving therapy. The proliferation of poor-quality and incomplete EDX testing by bad actors that often operate with little overhead and thus feel less impact from recent reimbursement cuts undermines the chance that medically necessary EDX procedures will be performed early in the disease state or that the number of studies performed will be extensive enough to diagnose complex diseases. Moreover, for common conditions including carpal tunnel syndrome, cervical and lumbosacral radiculopathies, and allows the correct treatment to occur sooner, saving healthcare dollars and decreasing patients' pain and suffering. The fact that sub-optimal, improper, and incomplete EDX studies continue to be reimbursed by CMS represents a noticeable loss of critical healthcare dollars. We hope to work with you and your colleagues to define quality standards and pursue additional opportunities to effectively reduce fraud and abuse.

Representative organizations met with CMS staff recently for an initial conversation on this issues, and the community was encouraged by the discussion that occurred at that time. Moving forward, we would like to more formally and regularly engage with CMS to ensure constructive progress continues to be made. In this regard, we hope to have a community stakeholder call with your office to receive an update on this issue and identify opportunities that we can support and assist CMS with advancing. ## **HHS Takes Action on Opioid Use Treatment**

In conjunction with the President's visit to the National Rx Drug Abuse and Heroin Summit, U.S. Department of Health and Human Services (HHS) announced a proposal to allow qualified physicians to prescribe the opioid use disorder treatment medication buprenorphine to an increased number of patients. The proposed change is designed to strike an appropriate balance between expanding access to this important treatment, encouraging use of evidence-based medication-assisted treatment (MAT), and minimizing the risk of drug diversion.

Buprenorphine is an FDA-approved drug used as part of MAT, which is a comprehensive way to address the recovery needs of individuals that combines the use of medication with counseling and behavioral therapies to treat substance use disorders. Buprenorphine, because of its lower potential for abuse, is permitted to be prescribed or dispensed in physician offices. This significantly increases its availability to many patients. When taken as prescribed,

buprenorphine is safe and effective.

Under current regulations, physicians that are certified to prescribe buprenorphine for MAT are allowed to prescribe up to 30 patients initially and then after one year can request authorization to prescribe up to a maximum of 100 patients. This cap on prescribing limits the ability of some physicians to prescribe to patients with opioid use disorder.

If adopted, the proposal will allow for a qualified and currently waivered physician to prescribe buprenorphine for up to 200 patients. HHS welcomes public comment on this proposed rule. The 60 day comment period on the proposal opened on, March 30, 2016. HHS Secretary Sylvia Burwell has made addressing opioid misuse. dependence, and overdose a priority. The evidence-based HHS-wide opioid initiative focuses on three priority areas that include: informing opioid prescribing practices, increasing the use of naloxone (a rescue medication that can prevent death from overdose), and expanding access to and the use of MAT to treat opioid use disorder. These efforts build on work that began in 2010, when the President released his first National Drug Control Strategy, which emphasized the need for action to address opioid misuse and overdose, while ensuring that individuals with pain receive safe, effective treatment. Also in 2010, the ACA improved access to substance use disorder treatment options by requiring coverage of substance use disorder services in the Health Insurance Marketplace and establishing important parity protections to ensure that substance use disorder coverage is comparable to medical and surgical care coverage.

#### CMS Awards Round 2 Recompete Contracts for Competitive Bidding

The Centers for Medicare & Medicaid Services (CMS) recently announced the Round 2 Recompete and national mail-order recompete contract suppliers for Medicare's Durable Medical Equipment, Prosthetics, Orthotics, and Supplies (DMEPOS) Competitive Bidding Program. This program has been in effect since 2011 and is an essential tool to help Medicare set appropriate payment rates for DMEPOS items, save money for beneficiaries and taxpayers, and ensure access to quality items.

Under the program, DMEPOS suppliers compete to become Medicare contract suppliers by submitting bids to furnish certain items in competitive bidding areas (CBAs). After the first two years of Round 2 and the national mail-order programs (July 1, 2013 - June 30, 2015), Medicare has saved approximately \$3.6 billion while health monitoring data indicate that its implementation is going smoothly with few inquiries or complaints and has had no negative impact on beneficiary health outcomes.

The Round 2 and national mail-order program contract periods expire on June 30, 2016. Round 2 Recompete and the national mail-order recompete contracts will be effective from July 1, 2016 through December 31, 2018. The national mail-order recompete for diabetes testing supplies will be implemented at the same time as Round 2 Recompete and will include all parts of the United States, including the 50 States, the District of Columbia, Puerto Rico, the U.S. Virgin Islands, Guam, and American Samoa.

### Communication Regarding Medicare's Provider Enrollment Revalidation - Cycle 2

#### Dear Medical Society or Association:

First Coast Service Options (First Coast), your Medicare Administrative Contractor for the fee-for-service program in Florida, requests your help communicating important changes to your members to prevent potential loss of revenue to their practice or facility.

#### Provider Enrollment Revalidation Cycle 2

All Medicare Part A and B providers are required to recertify the accuracy of their enrollment information every five years through a process known as revalidation. The initial five year revalidation cycle was completed in 2015 and the Centers for Medicare & Medicaid Services (CMS) began Cycle 2 in March 2016.

CMS implemented improvements to streamline the revalidation process during Cycle 2. One enhancement is that CMS is establishing due dates with six months of advance notice for when the revalidation application must be received to remain compliant with Medicare's provider enrollment requirements. CMS posts the due dates for all currently enrolled providers in the Medicare Revalidation Lookup Tool at Data.CMS.gov/revalidation. A due date of "TBD" means that CMS has not set the date yet. Please do not send a revalidation application if there is NOT a listed due date. First Coast will return any unsolicited revalidation applications received earlier than six months before the due date, or when a due date is not yet listed.

The Revalidation Lookup Tool is updated every 60 days, so we encourage providers to check the tool periodically and respond timely once your due date is established. First Coast is also issuing notices by mail to providers two-three months before the due date.

## An important change for Cycle 2 is that failure to submit a revalidation application will result in possible deactivation of a provider's Medicare enrollment and billing privileges. Please note other important impacts:

- · If the revalidation application is received, but additional information is requested (through development) and not received within the 30-day timeframe, the provider's Medicare enrollment will possibly be deactivated
- $\cdot\,$  Requests for application submission extensions will not be granted
- $\cdot\,$  Be sure to submit the application fee, if applicable
